Sub: Application for Letter of Permission for functioning of Dr. V.H. Dave Homoeopathic Medical College and Smt. S.I. Patel (Ipcowala) Homoeopathic Hospital, Hahnemann House, Amul Dairy Road, Anand, Dist. Kheda with admission intake capacity of 125 seats (including 25 seats of EWS quota) for Undergraduate (BHMS) course and 09 seats in Postgraduate Course[MD(Hom.)], Organon of Medicine (03 seats), Materia Medica (03 seats), Repertory(03 seats) for academic year 2023- 24: reg.

Dr. V.H. Dave Homoeopathic Medical College and Smt. S.I. Patel (Ipcowala) Homoeopathic Hospital, Hahnemann House, Amul Dairy Road, Anand, Dist. Kheda is functional since 1972 has submitted an application for permission for sanction of 125 seats in BHMS course including EWS and 09 seats in Postgraduate course [MD(Hom.)] for the academic year 23-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. Medical Assessment and Rating Board for Homoeopathy (MARBH) has examined the profile of the College as to whether the college fulfils the essential standards to be fulfilled as per the prevailing regulations under NCH Act 2020.

MARBH has examined the application and observes that the College shall fulfil the following functional requirements as per the required minimum standards:

- (a) Teaching Faculty (Department wise) to be appointed: Reader in Anatomy; Professor in Physiology; Reader in Pharmacy; Professor in Pathology; Professor in Surgery; Professor in Community Medicine.
- (b) Case records should be maintained with demographic details of the patient such as name, age sex, address, phone number etc.
- (c) Case sheets shall be maintained with complete case analysis and evaluation and reperforation and made available in the medical record room for academic purposes of students.
- (d) Lab investigation report should be maintained properly in case records.
- (e) All follow-up attendance should be recorded on the case records.
- (f) Disease diagnosis shall be recorded in all case records as per ICD 11 criteria.

The above shortfalls observed in your College shall be rectified within a period of 30 days or before counselling for admissions initiates, whichever is earlier. The compliance report shall be submitted to the MARBH. Considering the above observations, and facilities available, MARBH has decided to issue conditional permission to Dr. V.H. Dave Homoeopathic Medical College and Smt. S.I. Patel (Ipcowala) Homoeopathic Hospital, Hahnemann House, Amul Dairy Road, Anand, Dist. Kheda, Gujarat with admission intake capacity of 125 seats (including 25 seats of EWS quota) for Undergraduate (BHMS) course and 09 seats in Postgraduate Course[MD(Hom.)], Organon of Medicine (03 seats), Materia Medica (03 seats), Repertory (03 seats) for academic year 2023-24.

All admissions shall be made from NEET & AIAPGET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under All India Quota shall be conducted by the Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT designated by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the MARBH after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by MARBH.
